 - not to select any of the submitted tenders without giving a reason,
 - to omit to consider any tender non-compliant with the requirements of this enquiry.

The Tenderers are not entitled to any claims against the Contracting Entity in the event of the above circumstances.

The Contracting Entity informs that the procedure is not based on the act of January 29, 2004 Public Procurement Law and, therefore, remedies laid down in the act are not available.
